**Trinity Catholic School Tuition Policy**

1. A family's entitlement to receive parish assistance and pay the parish rate of tuition is determined by the pastor.
2. It is **MANDATORY FOR EVERY TRINITY FAMILY** to register for the **FACTS Tuition Collection/ Management Program (www: online.factsmgt.com) ON OR BEFORE MAY 26, 2020**, whether you plan to apply for financial aid or not. If you plan to request financial aid to help with tuition, **PLEASE** do so at the same time. It is **ABSOLUTELY ESSENTIAL** that we know who will request financial aid at the same time you register for the program in order to guarantee that tuition assistance funds will be available to you.
3. Financial assistance is based upon the recommendation from Facts Management and the listed amount a family states as their ability to pay. It should be noted every family is expected to pay some minimal amount for tuition.
4. All families must participate in fundraising for the school and agree to raise \$400 by the end of all fundraising events; or agree to a fundraising buyout of **\$400**.
5. Tuition payments must be up to date in order to receive any academic records. Academic records include progress reports, report cards, NYS Assessment scores, or any other test scores.
6. If a student withdraws from Trinity Catholic School, all tuition must be paid before academic records will be released.
7. For students graduating from Trinity Catholic School, all tuition must be paid before academic records will be released.
8. An annual **non-refundable \$55** registration fee for each student is due before a student is placed in a class. Registration fees must be paid in full by **July 1, 2020**. **This fee is PAYABLE TO TRINITY CATHOLIC SCHOOL.**
